Senior Supportive Services (SSS)

Services To Assist Seniors Facing Health and/or Economic Difficulty:

- Through a referral process, SSS provides assistance and advocacy with housing, and other services seniors may need.
- Contactless home visits are conducted to monitor the seniors well being and determine the level of need for services through a assessments of needs.
- Through a referral process, SSS provides Life Line, PSE&G, Medicaid, assistance with the application process, etc.
- We provide telephone reassurance.
 Through regular phone calls, we ensure the safety and well being of seniors living alone.
- Home Based Supportive Services provide in home assistance & personal care for the frail, disabled and elderly.
- Programs provide up to date information on Covid 19 testing and referrals.

National Family Care Givers Program

National Family Care Givers program primary function is to provide relief to the Caregiver who has been caring for a elderly person. The program provides an array of services to the senior they are responsible of caring for, through in-home assistance and support.
